- 3. That Def lant Restaino is affiliated with the podcast 'Edge of the Falls' (hereinafter referred this s "podcast") and 'Edge of the Falls' Facebook page.
- 4. That Definition In the Chris' and the Chris' and the Chris' and the Chris' Exemption In the Chris'

- 5. That the 'Citizens United with John and Chris' podcast is recorded live on the social media platform Facebook.
- 6. In addition to posting content on the 'Citizens United with John and Chris' Facebook page,

  Defendant Restaino published posts on his personal Facebook page.
- 7. On or about August 24th, 2020, Defendant Restaino posted to his personal Facebook page about Plaintiff D'Angelo.
- 8. Defendant Restaino stated that Nick D'Angelo, "has a job with Niagara Co Social Services, also editor of the Niagara Reporter & own law practice. If you google his name there is an article in Buffalo News and Gazette. He is accused of coercing women to have sex with him for legal aid. Also raped a 14 year old in NFHS but Judge Morinello let him off and said he's a good kid. You can find that to in google." Attached hereto as EXHIBIT A is the Facebook post and specific comment made by Defendant Restaino.
- 9. In the same post, Defendant Restaino continued, saying, "he hurt a lot of women & one I personally know." *See* Exhibit A.
- 10. On or about Sunday, August 23rd, 2020, Defendant Restaino published a link to a Niagara Gazette article and stated, "It's always a great day for humanity when a rapist is scared.. see how it feels." Attached hereto as EXHIBIT B is a screenshot of the post made by Defendant Restaino.
- 11. On or about Saturday, August 22nd, 2020, Defendant Restaino published a link to a Buffalo news article and stated, "this is what justice looks like. Finally the rapist is scared."

  Attached hereto as EXHIBIT C is a screenshot of the post.

- 12. Upon information and belief, Defendant Restaino has mentioned Plaintiff D'Angelo as a "rapist" and "sexual predator" in his 'Citizens United with John and Chris' podcast which is recorded and posted live on Facebook.
- 13. Defendant Restaino, both in posts on 'Citizens United with John and Chris' Facebook page and during live podcasts has stated that Plaintiff D'Angelo "rapes" women despite giving no specific factual allegations.
- 14. Plaintiff D'Angelo is not a public figure.
- 15. Plaintiff D'Angelo has never pleaded guilty to rape.

## CAUSE OF ACTION FOR DEFAMATION

- 16. That Plaintiff repeats and re-alleges all statements from paragraphs one (1) through fifteen (15) of this Complaint as if set forth fully herein.
- 17. That Plaintiff D'Angelo is an attorney duly licensed to practice law in the State of New York with offices in both Lockport and Niagara Falls.
- 18. That on multiple occasions specified herein, Defendant Restaino has published false statements in writing on his personal Facebook page, and verbally during 'Citizens United with John and Chris' live broadcasts, regarding Plaintiff D'Angelo.
- 19. Defendant Restaino's statements were made in writing on his personal Facebook page which are viewable to the public and thousands of Facebook friends who see his posts.
- 20. The posts made by Defendant Restaino on his personal Facebook page, and verbal comments during live broadcasts of the 'Citizens United with John and Chris' podcast, were then shared, widely disseminated and commented on across the social media platform.

- 21. Defendant Restaino's intent was for these posts to be widely disseminated, read, interacted with and the information repeated.
- 22. Defendant, with the intent that the false statements be widely disseminated and repeated, posted defamatory and false statements as referenced herein.
- 23. Defendant Restaino knows that his personal Facebook page has thousands of followers and that the posts would be widely disseminated across the social media platform.
- 24. Defendant Restaino's false statements of Plaintiff D'Angelo being a "rapist" or that he "raped a victim" amount to stating that D'Angelo committed a felony which is defamation per se.
- 25. That the statements made by Defendant Restaino are and were false.
- 26. That Defendant Restaino knew or should have known that the statements were false.
- 27. That by knowing the falsity of the statements made, Defendant Restaino acted with malice.
- 28. Upon information and belief, that there are additional false and defamatory statements made by Defendant Restaino.
- 29. That the plain import of the names used to described Plaintiff D'Angelo made by Defendant Restaino was to impugn the credibility and injure Plaintiff D'Angelo's reputation in the community where he works as an attorney.
- 30.
